

DENZAI Establishes a Joint Venture with FTE in Saudi Arabia

Tokyo, Japan, February 14, 2024 – DENZAI K.K. (Kohki Uemura, President and CEO; Muroran, Hokkaido) announced that a group company - DENZAI Arabia Co. Ltd. and Fawaz Ali Alshammari Co. for transportation (hereinafter referred to as "FTE"), establish a joint venture company (hereinafter referred to as "JV") in Saudi Arabia.



A signing ceremony was held in Dubai, UAE on February 12 (Monday), local time, to mark the establishment of this JV.

Background of JV Establishment

Since the establishment of DENZAI Arabia Co. Ltd., a wholly owned subsidiary in Jubail, Saudi Arabia in 2023, DENZAI Group has received many inquiries about wind power construction, crane operations, and heavy lifting operations in the region. By establishing a 50-50 joint venture with FTE, a major local port and heavy lifting company, we will be able to provide a stable supply of high value-added services. The JV is expected to be completed by June 2024.
